- 1.2 SNS Pharma Limited trading as Greenwoods Pharmacy is registered with General Pharmaceutical Council GPhC and www.greenwoodspharmacy.co.uk is registered with MHRA for sales of medicine in UK.
- 1.3 The customer is under obligation to disclose true & accurate medical history when filling medical questions on the website.
- 1.4 Our UK registered prescribers can request for further information before an order is accepted.
- 1.5 Order can be rejected for any reason as may be deemed fit by the Company. This includes but not limited to where the supply would result in health risks, non-availability of products, long anticipated postage, in ability of customer to provide additional information requested etc.
- 1.6 In case of rejected order, money taken would be refunded within 30 days
- 1.7 Order accepted would be communicated to customer through their registered email

6. Returns, Refunds and Cancellation Policy

- 6.1 SNS Pharma Limited policies in respect of returns and refunds shall apply. It is your responsibility to contact SNS Pharma Ltd to seek clarification where interpretation of terms is needed.
- 6.2 You may request for a refund only if we are unable to fulfill your order as a result risk to your health.
- 6.3 We cannot accept returns request on processed orders after the medicine has been dispatched. Please note that Consumer contracts

(Information, Cancellation and Additional Charges) Regulations 2013 do not apply to the sale of medicinal products under a prescription.

- 6.4 We shall endeavor to ship the products based on customers' requirements (either next day or standard 2 day delivery) or within 30 days of accepting your order.
- 6.5 However, we would not be held liable for non-delivery as a result of circumstances beyond on our control .e.g shipment delay by the shipping company or non-availability of products.
- 6.6 If you return something because of an error on our part or because it's damaged or defective, we will refund any charges incurred in returning the item to us (either by a personalised pre-paid return label or by refunding your return postage costs up to 2nd class postage only).

We'll check all items returned as damaged or defective. In the event we find no fault, we reserve the right to re-charge you for the item/s and to recover our fees and expenses from you.

7. Delivery Policy

Here at SNS Pharma Limited we pride ourselves on excellent customer service.

- 7.1 We know that you don't want to wait days for your order to arrive. That's why we send every order with Royal Mail next day delivery or Second Class Post. Which means that, all being well, you should receive your parcel the following working day after it has been despatched or within 5 days. What's more, any order accepted before 1pm on a working day will be despatched on the same day.
- 7.2 However, although we promise to despatch your order quickly upon acceptance, it should be remembered that delivery is not guaranteed within this timescale and parcels can occasionally take longer to reach their destinations. Parcels sent to Northern Ireland, the Isle of Man, Isles of Scilly, the Channel Islands and certain parts of Scotland will usually take a little longer to arrive.
- 7.3 We deliver only to UK addresses
- 7.4 Based upon the weight of your item(s) you will have two options for your postage either Standard Postage or Next day delivery postage.

Standard postage cost £3.95 dependent on the normal weight and size of your order and will be sent Royal Mail Second Class and should take 2 - 4 working days for delivery. Should the item not arrive within this time scale please contact your local sorting office to ensure that they are not holding the item for you. Please note that Royal Mail do not class an item missing until 15 working days has passed as they say it can still be delivered until

this time. Replacements for undelivered orders won't be possible until after this time.

Next day delivery postage is £7.25 (on orders before 3pm) - items will be sent using Royal mail delivery.

- 7.5 When your order has been dispatched you will receive an e-mail notification advising of this.
- 7.6 Contact us if you have not received your parcel within standard days we will do anything we can to help. If an item sent by Royal Mail has not been received it can often be found at the local sorting office awaiting collection. If not, the Royal Mail has a specific procedure that we can follow in the event of a missing parcel. If your order has been dispatched with Royal mail next day delivery, we can track and trace it using their online system.

8. Customer Warranties

- 8.1 The customer undertakes to correctly fill in the consultation questionnaire contained in this revealing and disclosing all relevant information truthfully to the best of your knowledge.
- 8.2 Provision of false information shall invalidate this agreement.
- 8.3 You give your consent that your prescription can be fulfilled by Greenwoods pharmacy.
- 8.4 To provide additional information when required. If you do not provide additional information, we shall have the right to reject your order.

8. Complaints

- 8.1. The customers undertakes to stop the use of medication and contact their GP or Doctors immediately if they observed negative side effects due to the use of the medication.
